# ACHIEVEMENTS AND PERSPECTIVES

Turkmenistan is a major player in the Asian oil & gas market. The country's hydrocarbon resources are estimated at over 71 billion tons of oil equivalent, that is over 20 billion tons of oil and over 50 trillion cubic meters of natural gas. Given these figures, as of today, Turkmenistan holds the world's fourth-largest proven natural gas reserves after Russia, Iran, and Qatar. Currently, Turkmenistan's largest customer is the People's Republic of China. Turkmenistan also supplies gas to Turkey and will soon start supplies to Iraq.

# ACHIEVEMENTS AND PERSPECTIVES

«Turkmenistan, possessing some of the world's largest hydrocarbon reserves, has successfully developed its oil and gas sector. These achievements contribute to the country's economic and sustainable development, aligning with the Sustainable Development Goals (SDGs).

Turkmenistan actively supports the United Nations' Sustainable Development Goals. Significant for the oil and gas sector are SDG 7 (affordable and clean energy), SDG 9 (industry, innovation, and infrastructure), and SDG 13 (climate action). The country aims to increase the share of clean energy, implement innovative technologies, and minimize environmental impact.

One of Turkmenistan's priorities is reducing methane emissions, one of the most harmful greenhouse gases. The country cooperates with international organizations such as the United Nations Environment Programme and the Global Methane Pledge. Using advanced technologies and emissions monitoring allows Turkmenistan to control and reduce pollution levels effectively.

In recent years, Turkmenistan has successfully implemented several major projects to develop new oil and gas fields. One example is the Galkynysh field, the largest onshore gas field in the world. Developing such fields increases the country's export potential and ensures stable revenue, which can be invested in social and infrastructure projects.»

# ACHIEVEMENTS AND PERSPECTIVES

Turkmenistan is proceeding with the Turkmenistan-Afghanistan-Pakistan-India (TAPI) gas pipeline project. On September 11, 2024, the construction of the Serhetabat-Herat (Afghanistan) section of the TAPI gas pipeline was launched. The 1,853-km pipeline will deliver up to 33 BCMA natural gas from the Galkynysh gas field in Turkmenistan to three off-take points in Afghanistan, three off-take points in Pakistan, and a final off-take point at the Pakistan-India border to supply the Indian market.

Turkmenistan is developing its offshore fields in the Caspian Sea and onshore in the Balkan region. Currently, several leading IOCs are producing oil and gas from contractual areas in the Caspian Sea: ENI, Dragon Oil, Petronas, XRG (ADNOC) and others. The focus of this year's Conference will be the attraction of investment to offshore blocks, optimization of production from mature fields, and the next phase of development of the supergiant Galkynysh field, the largest onshore gas field in the world.

## COMMODITIES FOR THE ENERGY TRANSITION – STRATEGIC RESOURCES & INVESTMENT PATHWAYS

As the global push for cleaner energy accelerates, hydrocarbons and petrochemical feedstocks continue to play a vital role—fueling industrial processes, enabling innovation in materials, and supporting cleaner fuel technologies. With hydrocarbon reserves exceeding 71 billion tonnes of oil equivalent, Turkmenistan remains a key supplier of strategic resources. This session will explore how the country is advancing its energy and petrochemical sectors through investment, innovation, and sustainable development. Following the successful TEIF 2025 in Kuala Lumpur, where Turkmennebit and PETRONAS Carigali Sdn Bhd signed an MoU for the exploration of offshore Blocks 11, 12, 16, 21, and 23, the momentum continued in May 2025 in Ashgabat. There, SC "Turkmennebit", PETRONAS Carigali Sdn Bhd, and ADNOC XRG signed a Production Sharing Contract for Block I — marking a major milestone in offshore development. This session will spotlight recent advancements in Turkmenistan's energy sector, including new geological data, upcoming investment opportunities, and the strategic role of methane management and infrastructure expansion in supporting the country's long-term energy transition.
